ELECTRICITY SERVICE

A. Outside service for RV's will be provided for a charge of \$30.00 - \$50.00 per night. RV space is only provided for those groups that have a designated RV site as a main part of their basic program. RV space for attendees or an occasional vendor/exhibitor is not available; names and numbers of nearby RV Park Sites can be provided to clients.

C. Usage Fee for Electric Service for Vendors/Exhibitors on Show Floors inside center will be \$40.00 per 110 hookup (higher voltage price to be determined) or max 120 amps per single vendor.

D. FOR REGISTRATION AREA

\$50 per day for power hookup usage (110 only). Duplex Plug-in rental \$20 per box per show

E. FOR BANDS/ ENTERTAINMENT AREA

Fees to be determined based on power requirements.

F. FOR MEETING ROOMS

\$50.00 per day per meeting room for power hookup usage (110 only).

Availability and rate to be determined per group. **MCCCC does not provide extension cords or standard power strips.** Power installation on show floors must be provided by the exhibit company.

INSURANCE

A minimum of \$2,000,000 general liability insurance is required for all events. The Mississippi Coast Coliseum Commission must be named as additional insured. A Certificate of Insurance is also required from all subcontractors of the main group such as entertainment, production companies, exhibit companies, set installers, etc. Proof of Worker’s Compensation Insurance is also required from any company providing services to clients including but not limited to the ones mentioned above. In some instances (but not all cases), MCCC is able to provide insurance coverage for clients. The insurance premium will be stated at the time the insurance is shopped and must be prepaid by the client before move in of the group.

PARKING

A parking fee is charged to all clients using any portion of the facility:

Consumer shows - \$2.00 per person must be collected either directly from client or can be added to each admission ticket whether comp or paid (adults only).

All other events - \$5.00 per car

Those groups exempted from parking (the above stated conditions) are: Convention groups, High school/ college graduations, tradeshow not open to the public and functions with under 500 in attendance who are the sole user of the facilities at the time of the event. In these instances, the group may be charged for the parking lot attendants at a per guard rate; to be determined at the time of contract issuance.
